Triodos Bank has published its renewed energy vision, describing its approach to financing the energy transition. The bank focuses on areas such as energy storage, local electricity grids, energy efficiency and circular supply chains, while keeping strict exclusions in place for fossil fuels, nuclear power and non-green hydrogen.

How to trade your DRs on Euronext Amsterdam?

Since 18 June 2025, Triodos Bank Depository Receipts (DRs) are listed on Euronext Amsterdam. This means you can only buy or sell the DRs on Euronext Amsterdam through an investment account with a broker, and no longer directly through Triodos Bank. With a broker, you can choose when to buy or sell your DRs, giving you more flexibility and control. If you do not want to trade, you do not need to do anything and can simply keep your DRs. You will receive dividend, vote at shareholder meetings, and can always later decide to transfer them to a broker.
