Triodos Bank first pan-European bank to achieve certification as a B Corporation

Triodos Bank announced that is has become a Certified B Corporation today, at the official launch of the B Corp movement in Europe. Founded in 1980, Triodos Bank has become a reference point for sustainable banking globally. It joins over 1,200 leading sustainable businesses in 38 countries.

B Corps are a new type of company that use the power of business to solve social and environmental problems.

B Corp certification is to business what Fair Trade certification is to coffee or Organic certification is to food.

Triodos Bank was certified by the non-profit B Lab to meet rigorous standards of social and environmental performance, accountability, and transparency. The certification process includes a thorough evaluation of how Triodos Bank's practices impact its customers, stakeholders, the environment and co-workers.

Triodos Bank CEO Peter Blom: "A growing movement of successful, sustainable companies use business as a force for good and positive change. These B Corps create lasting value for all stakeholders, not for just for their shareholders. Sustainability is fully integrated in their business."

Peter Blom: "B Corp certification helps to increase awareness about sustainable business by distinguishing credible businesses that are genuinely committed to doing good. It also helps improve the sustainability performance of the certified businesses themselves. We are part of this movement and are delighted to become a certified B Corp ourselves."

B Corp certified companies include the Patagonia clothing company and Ben & Jerry's ice cream. In the US, South America, Canada and Australia 1,257 companies across 121 industries are B Corp certificated.

B Corporations are certified by the non-profit B Lab to voluntarily meet rigorous standards of social and environmental performance, accountability and transparency. Certified B Corporations distinguish themselves in a cluttered marketplace by offering a positive vision of a better way to do business; better for workers, better for communities and better for the environment.

The B Corporation community includes 1,257 companies from 38 countries and over 121 industries working together toward 1 unifying goal: harness the power of the private sector for public benefit and redefine success in business.
